Portfolio choice under space-time monotone performance criteria.

I will discuss the optimal investment problem of an investor with space-time monotone criteria. This case corresponds to the choice of zero volatility in the forward performance spde. Explicit solutions for the optimal wealth and optimal portfolio processes will be provided.
